- 44% of the respondents face mental gloom as a result of abusive behavior at home.
- Basic needs are seriously influenced of half respondents confronting aggressive behavior at home.
- 48% of the respondent's youngsters' schooling is severely influenced by aggressive behavior at home.
- 76% of the respondents don't know about laws identified with homegrown violence.
- 94% of the respondents don't know about any association/singular promotion dressing aggressive behavior at home.

The investigation shows that abusive behavior at home on ladies' is as yet winning in Akbar Nagar Area, Lucknow.

Proposals

The proposals featuring the jobs/administrations of different segments for lessening the event and commonness of aggressive behavior at home are scripted beneath under the significant heads:

Legal executive, Government, Police, NGOs, Health care uphold, Counseling, Awareness Generation and Sensitization, and media.

Legal executive

NGOs
